CIRCULAR

It is for general information to all the students getting admission through JoSAA/CSAB – 2024 at National Institute of Technology Nagaland that they should complete their admission procedure through **OFFLINE MODE (Physical Reporting)** from **10th August 2024 to 13th August 2024 (9:30 Hrs to 16:30 Hrs)** as per the guidelines provided by JOSAA/CSAB-2024. The academic session will start from **14th August 2024** onwards.

The students allotted through the PwD quota will be examined physically by the institutional medical board during the physical verification process at NIT Nagaland. If the candidate fails to clear the physical examination by the duly constituted Medical Board of NIT Nagaland, the allotted seat may be cancelled.

Students are advised to bring the following original documents during the physical reporting process at NIT Nagaland.

1. Class X Mark Sheet/Certificate or Birth Certificate (for Date-of-Birth).
2. Class XII Mark Sheet (Qualifying Examination).
3. Photo ID proof as per Govt. of India norms, especially Aadhaar Card/Pan Card.
4. JEE (Main) Admit Card.
5. Provisional Admission Letter (Final) issued by JoSAA/CSAB 2024
6. Certificate of category (SC/ST/OBC-NCL/GEN-EWS), if applicable [in the format available on the JoSAA/CSAB-2024 website, issued by the competent authority]. In case of OBC-NCL/GEN-EWS category, the certificate must be issued on or after 01st April 2024.
7. In case of PwD category, Physical Disability Certificate as per JoSAA/CSAB 2024 format.
8. Family Income Certificate (if applicable), issued on or after 01st April 2024 by an officer, not below the rank of Tehsildar in the States/UTs.
9. Medical Certificate as per JoSAA format.
10. Copy of the Online Payment receipt for the Balance 1st Semester Fee Payable to the Institute. (Refer to Annexure -I)
11. Undertaking Affidavit by Parents/Guardian (On Anti-Ragging) (To be given on Non-Judicial Stamp paper of minimum Rs.50/- and duly notarized.) Format is given in Annexure-II
12. Undertaking Affidavit by Student (On Anti-Ragging) (To be given on Non-Judicial Stamp paper of minimum Rs.50/- and duly notarized.) Format is given in Annexure-III
