CIRCULAR

It is for general information to all the students getting admission through JoSAA/CSAB – 2026 at National Institute of Technology Nagaland that they should complete their admission procedure through **OFFLINE MODE (Physical Reporting)** from **13th August 2026 to 18th August 2026 (9:30 Hrs to 16:30 Hrs)** as per the guidelines provided by JOSAA/CSAB-2026. The academic session will start from **19th August 2026** onwards.

The students allotted through the PwD quota will be examined physically by the institutional medical board during the physical verification process at NIT Nagaland. If the candidate fails to clear the physical examination by the duly constituted Medical Board of NIT Nagaland, the allotted seat may be cancelled.

Students are advised to bring the following original documents along with one set of self attested photocopies during the physical reporting process at NIT Nagaland.

1. Class X Mark Sheet/Certificate or Birth Certificate (for Date-of-Birth).
2. Class XII Mark Sheet (Qualifying Examination).
3. Photo ID proof as per Govt. of India norms, especially Aadhaar Card/PAN Card.
4. JEE (Main) Admit Card.
5. Provisional Admission Letter (Final) issued by JoSAA/CSAB 2026
6. Certificate of category (SC/ST/OBC-NCL/GEN-EWS), if applicable [in the format available on the JoSAA/CSAB-2026 website, issued by the competent authority]. In case of OBC-NCL/GEN-EWS category, the certificate must be issued on or after 01st April 2026 or valid till 31st August 2026 .
7. In case of PwD category, valid UDID card / valid Physical Disability Certificate as per JoSAA/CSAB 2026 format.
8. Family Income Certificate (if applicable), issued on or after 01st April 2026 by an officer, not below the rank of Tehsildar in the States/UTs. (in the prescribed format attached below)
9. Medical Certificate as per JoSAA 2026 format.
10. Copy of the Online Payment receipt for the Balance 1st Semester Fee Payable to the Institute. (Refer to Annexure -I)
11. Anti-Ragging Affidavit by Parent(s) / Guardian (To be printed on Non-Judicial Stamp paper of minimum Rs.50/- and duly notarized). Format is given in Annexure-III
12. Anti-Ragging Affidavit by Student (To be printed on Non-Judicial Stamp paper of minimum Rs.50/- and duly notarized). Format is given in Annexure-II
