CIRCULAR

It is for general information to all the students getting admission through JoSAA/CSAB – 2023 at National Institute of Technology Nagaland that they should complete their admission procedure through **OFFLINE MODE** (**Physical Reporting**) from **21**st **August 2023 to 23**rd **August 2023 (9:30 Hrs to 16:30 Hrs)** as per the guidelines provided by JOSAA/CSAB-2023. The academic session will start from **24**th **August 2023** onwards.

The students allotted through the PwD quota will be examined physically by the institutional medical board during the physical verification process at NIT Nagaland. If the candidate fails to clear the physical examination by the duly constituted Medical Board of NIT Nagaland, the allotted seat may be cancelled.

Students are advised to bring the following original documents during the physical reporting process at NIT Nagaland.

- 1. Class X Mark Sheet/Certificate or Birth Certificate (for Date-of-Birth).
- 2. Class XII Mark Sheet (Qualifying Examination).
- 3. Photo ID proof as per Govt. of India norms, especially Aadhaar Card/Pan Card.
- 4. JEE (Main) Admit Card.
- 5. Provisional Admission Letter (**Final**) issued by JoSAA/CSAB 2023
- Certificate of category (SC/ST/OBC-NCL/GEN-EWS), if applicable [in the format available on the JoSAA/CSAB-2023 website, issued by the competent authority]. In case of OBC-NCL/GEN-EWS category, the certificate must be issued on or after 01st April 2023.
- 7. In case of PwD category, Physical Disability Certificate as per JoSAA/CSAB 2023 format.
- 8. Family Income Certificate (if applicable), issued on or after **01**st **April 2023** by an officer, not below the rank of Tehsildar in the States/UTs.
- 9. Medical Certificate as per JoSAA format.
- 10. Copy of the Online Payment receipt for the Balance 1st Semester Fee Payable to the Institute. (Refer to Annexure II)
