# Subject: TO CONSIDER AND APPROVE THE PROPOSAL OF REQUISITION TO MHRD FOR THE SANCTION OF ADDITIONAL TEACHING / NON-TEACHING AND ADMINISTRATIVE POSTS

#### Discussions

The Registrar appraised that, the BOG in order to meet the requirements of man power for the proposed departments of Civil Engineering, Mechanical Engineering and Electronics and Instrumentation Engineering, it was resolved by Senate vide Resolution S006.03 to request MHRD to sanction additional teaching and non-teaching / technical / administrative posts.

Registrar informed that the sanctioned students strength for the existing B.Tech programmes is 180 students per year and for M.Tech/M.Sc is 70 students per year. In the current academic year 2019-2020, the sanctioned intake is 250 considering all courses and total number of students enrolled is 572 as per the sanctioned strength. As per the norms of faculty-student ratio of 1:12 for UG and PG, the teaching faculty required for the academic year 2019-2020 is 48 and accordingly the non-teaching staff requirement will be 53. MHRD has sanctioned 38 teaching posts and 32 nonteaching/technical/administrative posts so far

Therefore, Registrar requested the Board may accord permission to send the detailed

The Seniority shall be decided as follows,

## 1. For **Professors Category**:

- (i) Date of joining in the institute.
- (ii) If the date of joining in the institute is same then the date of acquirement of Ph.D., Degree is the criteria.
- (iii) If the date of joining in the institute is same and the acquirement of Ph.D., Degree are also same then the date of birth is criteria.
- (iv) If the date of joining in the institute is same, the acquirement of Ph.D., Degree and the date of birth are same then the Senate will decide the Professor to be nominated.
