	1. Majority of the course coordinators had completed lecturing 60 percent of the syllabus before the lockdown was announced. The remaining 40 percent of the syllabus can now be completed via online mode (Zoom, WebEx, Google classroom, WhatsApp Group etc.). Remaining portions of the syllabus has to be completed by 15th June 2020.
	2. Due to COVID19, the minimum 75 percentage attendance requirement to be relaxed for the ongoing session (i.e., January 2020 to May 2020).
	3. As Quiz 1 was already conducted before the announcement of lockdown, the

remaining Quiz 2 assessment can be done by giving assignments/conducting quiz or using any other mode as per the requirement of the concerned course coordinator.

- 4. A combined(Mid Semester Examination + End Semester Examination) examination for all the final year students of B.Tech/B.S.M.S/M.Tech/MSc. will be conducted online via Assignments, OPEN TEXTBOOK, Miniquizzes, viva voce OR any combination of these for 50 marks. The standard weightage of 30 marks for Mid Semester examination will be mapped either from the internal assessments like assignments/ mini quizzes/ viva voce/ combination of quizzes and assignments or from the combined (end semester + mid semester) examination. The weightages of internal assessments, mid semester examination (withdrawn) and combined (end semester + mid semester) examination shall be flexible and can be decided by the concerned course coordinator.
- 5. The students failing to appear for online mode of examination due to lack of internet service can appear for physical mode of examinations as and when the institute opens.
- 6. Remaining assessment and final project review for the final year students of all the UG and PG courses will be conducted through online viva voce and will be evaluated by the committee consisting of Project coordinator, Supervisor, HoD of the concerned Department, one external from the allied Department and a nominee from Dean Office (Academic).
- 7. The combined(End Semester + Mid Semester) examination for the B.Tech students (1st 3rd Year), 4th year B.S.M.S. and 1st Year (MSc &M.Tech) students will be conducted physically only after the opening of the institute. The standard weightage of 30 marks for Mid Semester examination will be mapped either from the internal assessments like assignments/ mini quizzes/ viva voce/ combination of quizzes and assignments or from the combined (end semester + mid semester) examination. The weightages of internal assessments, mid semester examination (withdrawn) and combined (end semester + mid semester) examination shall be flexible and can be decided by the concerned course coordinator.

BOG -02 TO CONSIDER AND APPROVE FOR ASSIGNING THE 14-6-2020 FUNCTION OF THE OF THE REGISTRAR TO PROF. R. KUMAR IN VIEW OF THE ANTICIAPTED VACANCY FOR THE POST OF REGISTRAR TO BE AROSE ON 30/6/2020 AND DELAY IN COMPLETING THE RECURITMENT PROCESS ON ACCOUNT OF COVID-19 PANDEMIC.

It is to inform the Board that the five years tenure of the present Registrar Shri Binod Doley, ends on 30.06.2020. Though Shri Binod Doley has joined the duty on 30/6/2015, the then management of NIT Nagaland has reckoned his date of joining with effect from 1/7/2015 and paid his salary and wages with effect from 1/7/2015 only and he has not been paid any salary and wages for 30/6/2015 (Please refer Annexure II). Therefore, Shri Binod Doley is completing his five years of tenure on 30/6/2020 and hence he will be relieved from duties with effect from 30/6/2020 (AN). NIT Nagaland has advertised the post of Registrar vide our Advt No. NIT-N/ RECT-NT/2020/07 dated 20.02.2020. The last date for the receipt of the applications have been extended thrice (1st Extension to 02.05.2020, 2nd Extension till 19.05.2020 and 3rd Extension within 16 days after lifting of lockdown in the State of Nagaland) with approval of the Board due to the extension of lockdown nationwide. Now the last date of receipt of application is within 16 days after lifting of lockdown in the State of Nagaland. It is expected that the completion of the recruitment process may stretch up to the end of September 2020.

In NIT Nagaland, at present, Dr. R. Kumar and Dr. (Mrs.) Themrichon Tuithung, in the rank of Professors are available for assigning this additional responsibility of Registrar (In-Charge). Dr. R. Kumar has joined the institute as Professor on 09/05/2016 and Dr. (Mrs.) Themrichon Tuithung, has joined the institute on 02/06/2016 as Professor. Dr. (Mrs.) Themrichon Tuithung has served as Director (In-charge) of NIT Nagaland for about 11 months earlier. Dr. R. Kumar is Dean (Academic) for the last three years and likely to be relived from this position soon on account of completing three years tenure. The Senate of NIT Nagaland has recommended Prof. R. Kumar as nominee of the Senate to BoG of NIT Nagaland. The BoG has also approved the nomination of Prof. R. Kumar to the BoG. Dr. R. Kumar residence is about 3.5 KM from the Institute and Dr. (Mrs.) Themrichon Tuithung is living about 18.5 KM from the Institute. Dr. R. Kumar's wife is pursuing Ph.D., in NIT Nagaland and Dr. (Mrs.) Themrichon Tuithung's son is pursuing his B.Tech., in ECE in the institute.

The next Senior Dr. Amrit Puzari, Assistant Professor may be considered for assigning responsivity of Registrar if there is an apprehension in considering the candidatures of Dr. R. Kumar and Dr. (Mrs.) Themrichon Tuithung for acting as Registrar (in-charge) because of the fact that their close relations are pursuing studies in the Institute. Dr. Amrit Puzari is living nearby the institute. It to be informed that his name is recommended for the consideration for the Appointment of Chief Vigilance Officer for the Institute. The Senate of NIT Nagaland has recommended Dr. Amrit Puzari as Page | 2 nominee of Senate to BoG of NIT Nagaland. The BoG has also approved the nomination of Dr. Amrit Puzari to the BoG.

As the position is for officiating as an in-charge in addition to his/her responsibilities for a brief period and also the responsibility shall only be given to a person serving in the institute, there is no selection process needed through DPC. Hence, it is proper to assign the additional responsibility of Registrar (In-charge) based on the seniority of the person in the institute. In view of the Seniority and close proximity of the residence to the institute, it is proposed to assign the function of the Registrar (In-Charge) to Prof. R. Kumar from the date of relinquishment of Shri Binod Doley, till the appointment of Regular Registrar in addition to his duties.

If there are some apprehensions on the Appointment of Prof. R. Kumar as Registrar (incharge), only on the ground that his spouse is pursuing her Ph.D., in the Institute, Dr. Amrit Puzari may be considered for the appointment of Registrar (In-Charge) from the date of relinquishment of Shri Binod Doley, till the appointment of Regular Registrar in addition to his duties. In this case the nomination of Dr. Amrit Puzari as CVO can be withdrawn and some other person may be nominated as CVO because of the fact that persons holding any decision making posts in the last three years shall not be nominated as CVOs as per the guidelines of CVC.
