FC & BOG	TO CONSIDER AND APPROVE THE PROCUREMENT OF WATER TANKER FOR TRANSPORTING WATER TO NIT NAGALAND CAMPUS	
	Discussion	Resolution
	<p>In NIT Nagaland there is acute shortage of water in the campus. The Dug well & Bore wells are not giving enough yield and inadequate to meet the present water requirement of Hostels, Quarters, Academic Blocks, Offices etc in the campus. Since last 15 days due to heavy shortage of water we requested the near by para-military units, police and other available sources to transport water to our campus. Even these units or sources could not provide fully requirement of NIT Nagaland as expected due to non-availability of either tanker or water in Dimapur city. It is also to be noted that the proposed water project from the river source through PHED, Govt of Nagaland is delayed due to delay in approval of the Cabinet. Therefore, till the water project is commissioned, we need to look for alternative options for meeting the water requirement in the campus. Even if the water project is completed in summer, the water scarcity in NIT Campus cannot be over ruled. Though the PHED, Govt. of Nagaland is planning to pump water of about 0.17 MLD from their water treatment plant during summer season to NIT Nagaland, there could be water shortage because of lack of availability of continuous electric supply. One viable option is brining water from the downstream riverside (i.e., from the low-level areas) through water tankers. Unfortunately, the water tankers are not available for hire and also raw water suppliers are not available in and around Dimapur for supplying water.</p> <p>In view of the water crisis in the campus, it is proposed to immediately procure vehicle with water tanker capacity of 9000 liters to use during such emergency for supplying water to different location in the</p>	<p>It is resolved that 01 No. of water tanker of 9000 liters capacity and Accessories like Motor pump, pipes etc, can be procured for NIT Nagaland for an estimated amount of Rs 15.00 lakhs for tanker plus Rs 1.00 Lakh for Accessories like Motor pump, pipes etc., using the funds from IRG through GeM.</p>

Institute View Point: Regarding the revision of user charges, we will put-up the proposal in our forthcoming FC and BoG. It is to be noted that only 5 quarters are available in the NIT campus and these are being occupied with 7 adults and 4 children only. There are 443 students are living in the hostels. In addition for the institute water is required for about 200 faculty/staff, 100 Ph.D., day scholars and laboratories. Hence, the proposed water tanker will be used for the purpose of catering to the students' needs in Hostels and Mess and the needs of the Institute and at present the water requirements for the faculty quarters is very marginal.
