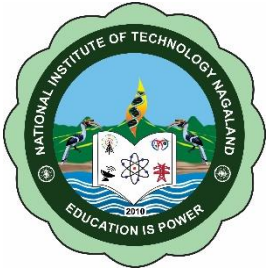

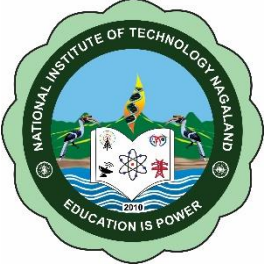

General Terms and Conditions

1- Obtaining Eol Document

The Eol Document can be downloaded from the website of the Institute, www.nitnagaland.ac.in from the date mentioned in the Bid Information Sheet. Please refer Tender section on the Home Page of the Website. Please keep visiting our website for any corrigendum / amendments and submit the bid documents accordingly.

2- Bidding Methodology

The bidding methodology adopted for this Eol shall be **two envelop system** i.e. The Bidders shall submit their proposal, **both Technical and Financial Bids at the same time in separate sealed envelopes**. The last date for submission of bids is as mentioned in the Bid Information Sheet. No bids shall be accepted after the date and time mentioned above. Financial bids shall be opened after physical visit (if required). The shortlisted firms shall be informed about the date and time of opening of financial bids.

3- The bid shall be signed by the individual legally authorized to enter into commitments on the behalf of the firm. Only one submission of response to Eol Document by each bidder will be permitted.

4- The documents required under the Eol conditions for submission along with the Eol are listed below. The bidder/s are advised to examine the various conditions and submit necessary documents accordingly. In case of non-submission of any of the desired information, the bid(s) may be considered non-responsive and are liable to be rejected outright.

Eligibility Criteria for Intending Hotel Empanelment and Rate Contract:

The eligibility criteria will be as per the supporting documents and details required to be filled in Annexure- I and II

Terms & Conditions:

1. NIT Nagaland is looking for Hotels/Resorts/Guest House for its Experts, Consultants, Guest Faculties and other guests visiting NIT Nagaland. Hotels/Resorts/Guest House having at least 10-15 rooms around Dimapur and Chumukedima preferably be located within the radius of 20 Km from NIT Nagaland.
2. The Eols are invited from reputed Hotels/Resorts/Guest House for rate contract for the period of two years.
3. We are looking for hotels where per day room tariff is for 24 hours from the time of check-in, Single/ Double occupancy/ Twin Sharing basis in well-appointed standard accommodation with amenities inclusive of facilities like air conditioning, 24-hour hot water and cold water facility and power supply, cleaned pressed bed sheet, bath towel, hand towel, 2 soaps, Two (02) Mineral water bottles, daily in each rooms, each day to each occupant / s. The expenses related to room rent and food on actual consumption basis will only be paid to the hotel. The hotel will have to collect all other individual expenses of personal nature from the room guest directly.
4. The period of contract will be two years with a provision for extension of validity after review of the performance at the end of two years. The increase in tariff will be decided mutually. The activation of escalation clause must be requested by the hotel. However, the rates quoted shall remain fixed during the two years of the contract.
5. During the period of contract, the Institute shall book different categories of rooms on the basis of requirement. NIT Nagaland will not commit to any guarantee for booking of Rooms during the contract period. However, on the basis of requirement and visitors/Guest at NIT Nagaland the Institute will contact empanelled Hotels for booking in advance.
6. The Hotel accommodation must have the facility to provide first aid and doctor on call facility for medical emergencies.
7. The food (Breakfast, Lunch and Dinner) may be provided as per the requirement of accommodating guest. If any limit is set towards the food charges for Guest, it will be intimated by the Institute.

8. Payment Terms: No Advance payment shall be made. Based on the actual booking of rooms, the empanelled hotels has to raise GST Invoice for Payment to the “Registrar, NIT Nagaland” with details on monthly basis. The bill if found correct for payment, will be paid within 15 days’ subject to bills being in order as required.
9. The bills raised by the Hotel shall clearly mention the billing components (basic tariff, taxes etc.) Check-in, Check-out details of guest(s) with guest signature.
10. Separate bills shall be raised for Room Booking, Food (Break Fast, Lunch and Dinner) and other arrangements.
11. TDS and TDS on GST will be deducted as per applicable.
12. Eol should be accompanied by Demand Draft for Rs.2000/-, drawn in favour of “IRG, NIT Nagaland”, towards the Registration Fee. This amount is non-refundable. Application without the prescribed tender submission fee will not be considered. And Earnest Money Deposit (EMD) of Rs.10,000/- (Rupees Ten Thousand Only). EMD of Empanelled Hotels shall be converted in to Performance Security.
9. The Institute accepts no responsibility for any loss/delay/non-receiptof offers. Offers received late/incomplete are liable for rejection.
10. The offers will be scrutinized by the committee constituted for the purpose. If required, the committee will visit the hotels to inspect the facilities and amenities claimed in the offer. The committee will recommend the names of hotels suitable for empanelment for each location. The decision of the committee will be final and binding to the bidders.
11. After inspection of facilities and evaluation of financial offers, the committee will recommend the names of hotels suitable for empanelment. While recommending the names, the committee will put great emphasis on amenities (**as prescribed in Annexure-I and II**) available in the hotel at competitive rates.
13. The Institute reserves the right to modify the conditions of the Eol, at any time, without assigning any reasons for the same.
14. The Institute reserves the right to accept/reject any offer in part or full, without assigning any reason whatsoever.
15. If the last date of receiving/opening of the offer coincides with a holiday, then the next working day shall be the receiving/opening date.

16. The final selection of hotel will be as per the following selection process:

- (i) Verification of documents by committee constituted for the purpose in support of eligibility criteria as mentioned in **Annexure- I and II**;
- (ii) Physical visit of hotel premises (if required) to check the services, amenities and credentials of the hotel by the committee constituted for this purpose for recommending the names of suitable hotels.
- (iii) Evaluation of financial offers by committee in view of amenities and competitiveness of rates;
- (iv) Recommendation of names of hotels suitable for empanelment; and
- (v) Approval of names of hotels suitable for empanelment by competent authority. The Institute may empanel more hotels as per the amenities and competitiveness of rates.
- (vi) The decision of the Institute in the matter will be final and binding to all the bidders.

17. Neither the contract nor any rights granted under the contract may be sold, leased/sublet, assigned, or otherwise transferred, in whole or in part, by the vendor, and any such attempted sale, lease, assignment or otherwise transfer shall be void and of no effect. The vendor shall not subcontract or permit anyone other than its personnel to perform any of the work, service or other performance required of the vendor under the contract.

18. Penalty

The hotel should ensure regular and uninterrupted quality services at all times. In case of failure in services or negligence (as defined below), appropriate punitive action shall be taken by the Institute, which also includes monetary penalty not exceeding 5% of total monthly bill payable to the hotel.

Failure of service and negligence shall be measured in terms of the following:

- 1. Not providing accommodation and services as per the booking;
- 2. Any other matter which is an act of negligence or breach of ethics by the hotel.

18. Arbitration and Dispute Resolution

Any dispute and or difference arising out of or relating to this contract will be resolved through joint discussion of the authorities/representatives of the concerned parties. However, if the disputes are not resolved by joint discussions, then the matter will be referred for adjudication to the **Director**.

19. Jurisdiction of Court

The courts at Dimapur shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.

1. Technical Bid

- i) The envelop consisting of Technical Offer shall be marked as “Technical Bid” The specifications mentioned in the technical bid should be without any conditions.
- ii) The technical bid must be filled in completely, without any error, erasures or alterations as per the specified in **Annexure-I (Format-A & B)**.
- iii) The specifications should be mentioned in clearly readable format without any overwriting.
- iv) The technical bid shall be on a fixed basis and, no variation in any specifications shall be considered.
- v) Technical bid written with vague and conditional expression(s) will be treated as being at variance and shall be liable for rejection.
- vi) It is the responsibility of the Bidder to clearly identify all specifications associated with any item or series of items in this EoI Document and submit the details in the technical bid.
- x) The bidder shall ensure that there is no discrepancy in the details mentioned in technical bid.
- xi) The bidder must fill and submit the details as per instructions given above. If the bidder does not mention any specification for any item in the technical bid, his EoI may be summarily rejected.
- xii) The bidder may enclose the brochure of the hotel if available.

2. Financial Bid

- i) The envelop consisting of Financial Offer shall be marked as “Financial Bid” The prices quoted in the financial bid should be without any conditions.
- ii) The price bid must be filled in completely, without any error, erasures or alterations as per the specified format given in **Annexure-II (Format-A & B)**.
- iii) The prices should be mentioned in Indian Rupees only in clearly readable format without any overwriting.
- iv) The Financial bid shall be on a fixed price basis and, no price variation on any account shall be considered for the first two years.
- v) Price quotation accompanied by vague and conditional expression(s) will be treated as being at variance and shall be liable for rejection.
- vi) The taxes payable should be inclusive thereof.
- vii) The bidder shall ensure that there is no discrepancy in the rates mentioned in figures and words. In case of any discrepancy, the unit rate mentioned in the words shall be taken as final and binding.

PROVISIONS REGARDING FRAUDULENT PRACTICES AND INTEGRITY PACT

NIT Nagaland requires that the Bidders under this EoI observe the highest standards of ethics during the procurement and execution of such contracts. In pursuance of this policy, the Institute.

- a. Defines for the purposes of this provision, in the terms set forth as follows:
- *Corrupt practice* means the offering, giving, receiving or soliciting of anything of value to influence the action of any NIT Nagaland official in the procurement process or in contract execution; and
 - *Fraudulent practice* means a misrepresentation of facts in order to influence a procurement process or execution of a contract to the detriment of NIT Nagaland and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Institute of the benefits of free and open competition.
- b. Will reject a proposal for award if it determines that the Bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question.
- c. Will declare a firm ineligible, either indefinitely or for a stated period of time, to be awarded a contract if it at any time determines that the firm has engaged in corrupt and fraudulent practices in competing for, or in executing, a contract.
- d. The past performance of the Bidder will be cross checked if necessary. If the facts prove the same to be dubious, the Bidders EoI will be ineligible for further processing.

For the purpose of this EoI the provisions of Integrity Pact as described in the order dated 6th July 2013 of Dept. of Finance, Govt. of CG shall be abided by all the parties.
